PLEASE NOTE: If entry is not large enough to support three days, OLGD will begin at 8:00 a.m on Saturday. Any changes will be noted at the time running orders are sent out to participants.

The Amateur Gun Dog is a retrieving stake and will have call backs for the retrieve.

COURSES AND BIRDS

All stakes single course. Horseback handling will be allowed in all stakes except Amateur Walking Derby. No wrangler horses will be provided. All Stakes will have Quail released. Gunshots will be required in all stakes.

NOTE: Only blank guns with solidly filled barrels will be permitted.

AKC approved tracking collars allowed, but not provided.

Entries withdrawn after the draw will NOT be refunded unless a bitch is in season or a dog is injured. An injured dog must have a note from a veterinarian to receive a full refund.

The CWVC reserves the right to cancel the Trial due to inclement weather. If the trial is cancelled by the CWVC, full refunds will be given.
